



## Meeting Rules for 2022 Annual Meeting of Stockholders of Sunrun Inc.

In order to provide stockholders an opportunity to be heard, and in the interest of conducting an orderly meeting within a reasonable time period, we will be observing the following rules of conduct for the 2022 annual meeting of stockholders (the "Annual Meeting"):

- **Participation.** Only stockholders of record at the close of business on April 7, 2022, or their duly authorized proxies, are entitled to vote and submit questions at the Annual Meeting. To vote or submit questions, please log in to [www.virtualshareholdermeeting.com/RUN2022](http://www.virtualshareholdermeeting.com/RUN2022) using the 16-digit control number included in your proxy card.
- **Order of Business.** The only business to be conducted at the Annual Meeting are the proposals set forth in the Notice of 2022 Annual Meeting of Stockholders and in the Proxy Statement. The business of the Meeting will follow the order shown in the above Agenda.
- **Chair of the Meeting.** The chair of the Annual Meeting has the authority necessary to preside over the Annual Meeting and may make any and all determinations with respect to the conduct of the Annual Meeting and procedures to be followed during the meeting.
- **Voting.** You do not need to vote at the Annual Meeting if you have already voted in advance of the Annual Meeting. However, if you wish to change your vote, or if you have not previously voted, you may vote online during the Annual Meeting while the polls are open. The polls will close shortly following the presentation of the last agenda item being voted on.
- **Questions.** Stockholders will have the opportunity to submit questions during the Annual Meeting.
  - If you are a stockholder and wish to submit a question, beginning at 8:15 a.m. Pacific on Thursday, June 2, 2022, you may log into the Annual Meeting website listed above.
  - If you are a stockholder and wish to submit a question about one of the matters being voted on at the Annual Meeting, the question can be submitted online at the website listed above at or before the time the matters are before the Annual

Meeting for consideration. We will answer appropriate questions regarding matters voted on at the Annual Meeting before voting is closed.

- Questions allowed during the Annual Meeting must pertain to the proposals set forth on the agenda of the Annual Meeting. We kindly request that stockholders limit their questions to one topic per question and to one question per stockholder.
- Similar questions on the same topic may be combined.
- When submitting a question, please provide your name and your relationship to the Company.
- Questions or comments unrelated to the Annual Meeting or of individual concerns rather than of general concern to all stockholders may be submitted by contacting our Investor Relations team at [investors@sunrun.com](mailto:investors@sunrun.com).
- **Presentation of Stockholder Proposal.** During the presentation of the stockholder proposal, the stockholder proponent will have three minutes to introduce their proposal or make a supporting statement. Management's position on the stockholder proposals is stated in the proxy materials you received.
- **Issues During the Annual Meeting.**
  - If you encounter any difficulties accessing the Annual Meeting, please call the support number which appears on the login page.
  - In the event of disorder, technical malfunction, or other significant problem that disrupts the Annual Meeting, the Chair may adjourn, recess or expedite the Annual Meeting or take such other action that the Chair determines is appropriate in light of the circumstances.
- **Recording.** The Company will record the Annual Meeting and a replay of the Annual Meeting will be available and will be available for one month following the Meeting. Any other recording of the Meeting is prohibited.
