

UNITED NATURAL FOODS, INC. ANNUAL MEETING OF STOCKHOLDERS

ONLINE MEETING GUIDELINES AND RULES OF CONDUCT

We welcome you to the Annual Meeting of Stockholders of United Natural Foods, Inc. ("UNFI"). We are holding the meeting online to enable more of our stockholders to attend and to realize efficiencies compared to holding an in-person meeting. The online meeting is designed to enable stockholders who attend to have the same rights and opportunities to participate as if the meeting were an in-person meeting. We have developed these guidelines and rules to promote meaningful stockholder participation and in the interest of having a fair, informative, orderly, and constructive meeting that is more widely available to all of our stockholders, as opposed to only those who would have the time and means to travel to our headquarters for an in-person meeting.

Attending the Meeting

The meeting will be held online at 4:00 p.m. Eastern Time on Tuesday, December 17, 2024. If you were a stockholder as of the record date (October 23, 2024) and would like to attend the meeting, please access the meeting portal at the web address below fifteen minutes prior to the meeting (3:45 p.m.) and login by entering the 16-digit control number previously sent to you. If we experience technical difficulties during the meeting (e.g., a temporary or prolonged power outage), we will determine whether the meeting can be promptly reconvened or whether it should be reconvened on a later day. We will promptly notify you of the decision on the virtual meeting website. If you encounter technical difficulties accessing our meeting or asking questions during the meeting, a support line will be available on the login page of the virtual meeting website, shown below.

Participating in the Meeting

- (1) If you were a stockholder as of the record date (October 23, 2024), we encourage you to ask questions prior to and during the meeting by submitting written questions in the designated section of the annual meeting portal. The meeting portal is available to receive your questions in advance that you desire to be addressed during the meeting, and questions will be received until the end of the question-and-answer portion of the meeting.
- (2) When asking a question, whether in advance or during the live meeting, please identity yourself by your name and organization and indicate your status as a stockholder.



- (3) Questions will be directed to the meeting chairperson. We will direct questions in the form they were submitted unless a question contains profanity or derogatory references, relates to personal grievances, substantially repeats statements made by other stockholders, is unduly prolonged, or is not relevant to the business or operations of UNFI.
- (4) In the interest of time, we may consolidate answers to similar questions. We will prioritize questions from stockholders who identify themselves by name.
- (5) To ensure that as many stockholders as possible are able to ask questions during the meeting, each stockholder will be permitted no more than one question or comment.
- (6) The questions and comments of all stockholders are welcome, but the meeting is not to be used as a forum to present general economic, political or other views that are not directly related to the business or operations of UNFI.
- (7) During the question-and-answer portion of the meeting, we will answer questions that are submitted online during the meeting and will also address those that are submitted in advance of the meeting through the meeting portal, in both cases as time permits. You may also submit questions in advance of the meeting by visiting www.proxyvote.com, entering your control number and submitting a question through the "Submit a Question for Management" option.
- (8) After the meeting, we will post responses to questions that we do not have sufficient time to answer during the meeting on our website.

Agenda

The business of the meeting will follow the order shown on the agenda. The only matters to be presented for a vote at the meeting are the proposals set forth in the proxy statement previously made available to you.

Voting at the Meeting

If you were a stockholder as of the record date (October 23, 2024), we encourage you to vote in advance of the meeting. If you have already voted by proxy, there is no need to vote at the meeting unless you wish to change your vote. You may vote or change your prior vote through the web portal during the online meeting until the meeting chairperson or secretary has announced that the polls have closed. No further voting will be permitted after the closing of the polls.
