

## **RULES OF CONDUCT AND PROCEDURES**

### **2023 ANNUAL MEETING OF STOCKHOLDERS OF DECISIONPOINT SYSTEMS, INC.**

Welcome to the 2023 Annual Meeting of Stockholders (the “**Annual Meeting**”) of DecisionPoint Systems, Inc. (the “**Company**”). It is our desire to conduct a fair and informative Annual Meeting. Kindly observe the following Rules of Conduct and Procedures.

1. All questions as to the conduct of the Annual Meeting and the procedure being followed at the Annual Meeting shall be decided by the Chairman of the Annual Meeting. The Chairman may consult with such persons as he deems appropriate in arriving at any such decisions.
2. As described in the proxy statement, stockholders and their proxy holders are permitted to ask a question during the Annual Meeting. Stockholders will need to have held stock as of the close of business on the record date of November 7, 2023 to vote or submit a question while participating in the virtual Annual Meeting. To vote or submit a question, please login by entering the 16-digit control number you received with your proxy materials. If you have voted your shares prior to the start of the Annual Meeting, your vote has been received by the Company’s inspector of election and there is no need to vote those shares during the Annual Meeting, unless you wish to revoke or change your vote.
3. All questions must be submitted in English.
4. The only items of business that may be considered and voted on by the stockholders at the Annual Meeting are the ones set forth in the notice of the Annual Meeting and the proxy statement.
5. If a stockholder has a question about one of the proposals to be voted on by the stockholders at the Annual Meeting, such question may be submitted in the “Ask a Question” field provided in the web portal at or before the time the matters are before the Annual Meeting for consideration. We will answer questions on any proposals to be voted on by the stockholders at the Annual Meeting before the voting is closed.
6. Following adjournment of the formal business of the Annual Meeting, the Company will address appropriate general questions from stockholders regarding the Company. Such questions may be submitted in the “Ask a Question” field provided in the web portal during the Annual Meeting.
7. Each stockholder is limited to one question. It will help us if questions are succinct and cover only one topic per question. Questions from multiple stockholders on the same topic or that are otherwise related may be grouped, summarized and answered together.
8. Stockholder questions are welcome, but conducting the business set out in the notice of the Annual Meeting and the proxy statement for the benefit of all stockholders will be paramount. The Company will not address any questions that are:
  - a. not pertinent to Annual Meeting matters or the business of the Company;
  - b. related to material non-public information of the Company;
  - c. related to personal grievances;
  - d. offensive or otherwise contain inappropriate language;
  - e. derogatory references to individuals or that are otherwise in bad taste;
  - f. statements repetitious of those already made by another stockholder;
  - g. in furtherance of the stockholder’s personal, political or business interests;
  - h. related to personnel matters or doing business with the Company; or
  - i. out of order, inappropriate or otherwise unsuitable for the conduct of the Annual Meeting as determined by the Chairman in his judgment.

9. Upon closing of voting, stockholders will be able to ask general business questions. To ensure all stockholders are able to attend and participate in the entire Annual Meeting, the Company expects to adjourn the meeting no later than 10:00 a.m. Pacific Time.
10. Recording of the Annual Meeting is prohibited. We expect that a webcast playback will be posted approximately 24 hours after the completion of the meeting at the Investor page of the Company's website at <https://www.decisionpt.com/investing-in-decisionpoint/>.
